The Pretrial Services Assessment is comprised of 9 risk factors obtained from a defendant's criminal history and current charge. These factors are weighted and combined to evaluate the risk that, if a defendant is released before trial, they will:

- Commit a violent crime (NVCA)
- Commit any new crime (NCA)
- Fail to appear for court (FTA)

RELATIONSHIP BETWEEN RISK FACTORS AND PRETRIAL OUTCOMES

7. Prior failure to appear in the past two years	X	X	
8. Prior failure to appear older than two years	X		
9. Prior sentence to incarceration		X	

FTA Scale

0-1 = Low

2-5 = Moderate

6-7 = High

NCA Scale

0-2 = Low

4-8 = Moderate

9-13 = High

Note: Boxes where an "X" occurs indicate that the presence of a risk factor increases the likelihood of that outcome for a given defendant.

4. **Click** either *Pretrial Reports* button.
 - The Pretrial Reports button in the blue banner will download ALL pretrial reports associated with the searched party for ALL cases the CourtNet user has opted into.
Note: Prosecutors will see all reports, regardless of opt-in status.
 - The Pretrial Reports button in the Actions column will download ONLY the pretrial reports associated with the individual case listed on the left.
Note: eFile-only users will see only the Pretrial Reports button for individual cases.
