Pretrial Interview Report

eFilers (KBA) may now access the Pretrial Interview Report in CourtNet for cases the eFiler has opted into electronically. The report may be accessed using the Pretrial Report in the search results on the blue banner or by using the Pretrial Report action. A Quick Reference Guide can be found [here](#).

CourtNet Search Results

The Pretrial Reports button in the blue banner will download all pretrial reports associated with the searched party for all cases the CourtNet user has opted into. To download the Pretrial Interview Report in the search results on the blue banner:

1. Login to KYecourts

2. Select Case Search (CourtNet)



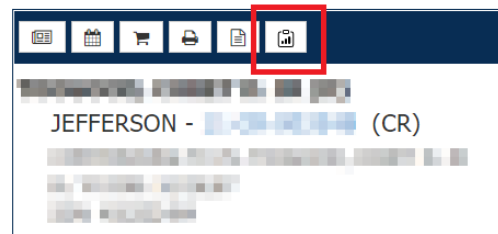
3. Search for desired case by case number or party/business.



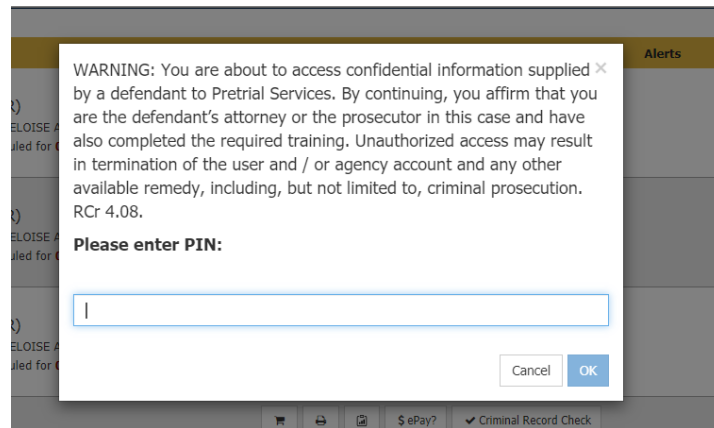

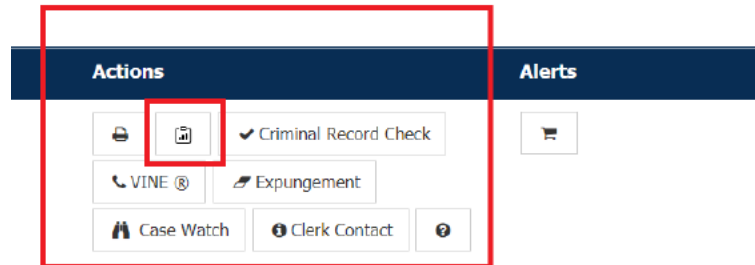

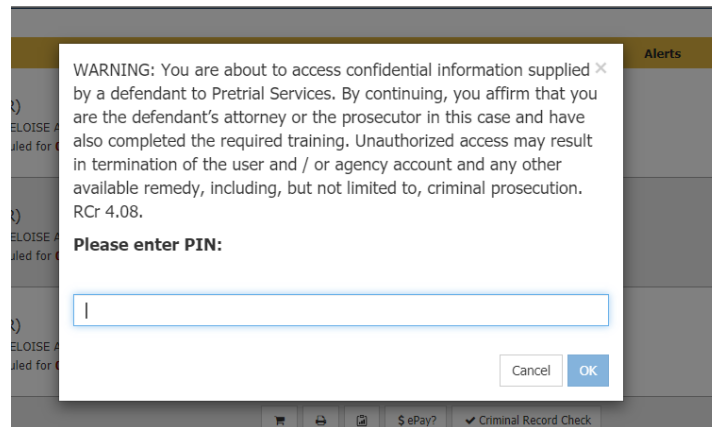
Pretrial Report Action
